

# Terms of Use

## Acceptance of these Terms

By using Right Direction Church International sites, services and mobile applications (together, “Right Direction sites”), whether as a guest or a registered user, you accept and agree to be bound by these Terms. Please read these Terms carefully before you start to use Right Direction Church International sites, as well as the Right Direction Church International Privacy Policy. If you do not agree to these Terms or the Right Direction Church International Privacy Policy you must not access or use the Right Direction Church International sites.

## Changes to the Terms

Right Direction sites are offered by Right Direction Ministries, Inc. (“Right Direction”, “we” or “us”). We may revise and update these Terms from time to time at our sole discretion. Any changes are effective when we post them. Your continued use of a Right Direction site following the posting of revised Terms means that you accept and agree to the changes.
